



TERMS AND CONDITIONS OF THE PROMOTIONAL OFFER: “10% MORE WITH DOLADOWANIA.T-MOBILE.PL”

1. Basic information about the offer

- 1.1. You can benefit from these promotional terms and conditions from 20 November 2022 until they are withdrawn by T-Mobile Polska S.A. (hereinafter “T-Mobile”).
- 1.2. These terms and conditions apply to:
 - Users of the GO!, Frii tariffs in the prepaid T-Mobile, Blueconnect prepaid Internet systems; and
 - Subscribers of the Frii Mix tariff in the Mix system.

2. What will you get?

- We offer you an additional top-up amount, equal to 10% of the top-up executed through www.doladowania.t-mobile.pl or www.doladuj.heyah.pl (hereinafter the “Bonus”).

3. How does it work?

- 3.1. The Bonus will be granted on the condition that the account is topped up with the minimum amount of PLN 35 through the website <https://www.doladowania.t-mobile.pl> or <https://www.doladuj.heyah.pl> during the promotional period.
- 3.2. The bonus will be added to your account within up to:
 - 7 days after the condition for its receipt is met, i.e. after a top-up in accordance with item 3.1.
 - 14 days after the condition for its receipt is met if you are in roaming at the time of the top-up
- 3.3. You use this offer multiple times.
- 3.4. When the Bonus is added to your account, you will receive a text message confirmation.

 - 5.1.3. does not extend the Account Validity;
 - 5.1.4. does not extend the promotion units accumulated on the account and other services;
 - 5.1.5. and does not entitle you to any additional GB under the “GB on top-up” promotion.
- 5.2. The period by which the top-up extends the validity of the account for outgoing calls is determined solely on the basis of the top-up amount without the Bonus.
- 5.3. The funds granted as part of the Bonus can be used on the condition of having a valid account for outgoing calls.
